# **GENERAL SALES CONDITIONS**

#### 1. GENERAL

The general sales conditions, here below, are valid for any order received by ATI Applicazioni Tecnologie ad Iniezione Spa and they represent an essential part of each order. Any changes to these clauses and any special condition must be expressly agreed in writing.

#### 2. ORDERS

The orders acquired by our sales organization will be considered approved by ATI Applicazioni Tecnologie ad Iniezione Spa trough the order confirmation which will be sent by email. After two days from the transposition of the order confirmation and without any feedback from the customer it will be considered approved and accepted.

## 3. TRANSPORT

Depending on the type of delivery conditions agreed and indicated on the order confirmation, any risk and danger concerning the transport has to be assigned to the customer or to the supplier on the basis of INCOTERMS 2020. Any customer complaint must be advanced directly to the carrier at the moment of delivery.

## 4. SHIPMENT CONDITIONS

The delivery terms are indicated on the order confirmation. However ATI Applicazioni Tecnologie ad Iniezione Spa reserves the right to change the expected delivery date, for reasons of force majeure, after informing the customer.

## 5. PRICES

All prices indicated in the order confirmation have to be considered VAT EXCLUDED. ATI Applicazioni Tecnologie ad Iniezione Spa reserves the unquestionable right to make changes to the price list published in case the components cost of the individual articles makes it necessary. #### 6. CLAIMS

Any complaints must be sent in writing to ATI Applicazioni Tecnologie ad Iniezione Spa within 8 days from receipt of the goods. The return of the goods must be previously authorized by ATI Applicazioni Tecnologie ad Iniezione Spa. The authorized returns have to be sent to ATI Applicazioni Tecnologie ad Iniezione Spa warehouses, in agreement with the commercial department about the payment of transport costs, accompanied by a regular transport document and relative purchase details. The goods will be credited to the purchase price if, at the discretion of ATI Applicazioni Tecnologie ad Iniezione Spa, it will be intact as delivered and not damages.

### 7. MEASURES AND DRAWINGS

Indications of measurements and drawings on any publication ATI Applicazioni Tecnologie ad Iniezione Spa are to be intended purely for information and may be subject to changes without notice.

### 8. PAYMENTS

Payments should be made to ATI Applicazioni Tecnologie ad Iniezione Spa on the expiration date and for the agreed amount. Any delay in the payment of the invoices after the deadline gives rise to the immediate beginning of the bank interests and may involve a consequent suspension of supplies.

#### 9. PROPERTY OF THE GOODS

ATI Applicazioni Tecnologie ad Iniezione Spa remains the owner of the goods until full payment.

### 10. RELEVANT COURT

In case of dispute the Court of Vicenza will be competent.
